General Program Information

What is the T.E.A.C.H. Early Childhood® Scholarship Program?

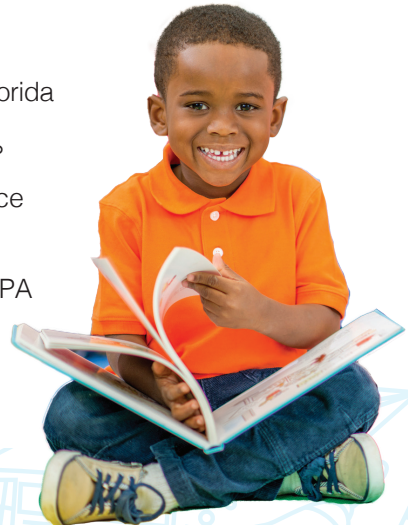
The T.E.A.C.H. Program:

- Is a national strategy that links professional development, increased compensation, and a commitment to remain in the early learning profession – **T**eacher **E**ducation **A**nd **C**ompensation **H**elps.
- Creates a three-way partnership between the scholar, their employer, and the T.E.A.C.H. Early Childhood® Scholarship Program, with all three contributing to tuition costs and other expenses.
- Provides scholarships and support to those working with young children, including early learning educators and directors, family child care educators and owners, out-of-school-time educators, and child care facility owners.
- Offers a variety of scholarships to fit your professional development goals. These include:
 - Florida Staff Credential (initial or renewal)
 - Director Credential (initial or renewal)
 - National CDA Assessment
 - College Credit Certificates
 - Associate, Bachelor's, or Master's degrees in early childhood education

What are some examples of T.E.A.C.H. success?

T.E.A.C.H. highlights include:

- Helping provide a highly-educated and well-compensated ECE workforce in the state of Florida
- Reducing turnover in the field to less than 5%
- Awarding more than 67,000 scholarships since the program began in 1998
- Maintaining an average T.E.A.C.H. scholar GPA of 3.4 or higher
- Working with 62 training programs, colleges, and universities across the state



General Program Information

Who is eligible for a T.E.A.C.H. scholarship?

Teachers, directors, owners, or family child care educators may be eligible if they:

- Are Florida residents
- Have a high school diploma (regionally accredited) or GED
- Are employed by a licensed, license-exempt, or registered program, including child care facilities, family child care homes, and out-of-school-time programs
- Work or volunteer a minimum of 20 hours a week with young children, birth through Pre-K (or 520 hours per year for out-of-school-time)
- Have support and sponsorship from their employer

What does the T.E.A.C.H. scholarship cover?

The scholarship provides:

- The majority of the cost of tuition and books
- A per semester student access stipend*
- A tiered bonus structure for degree-seeking scholars*
- A reimbursement to the employer for the paid release time provided to scholars*
- Administrative support with access to a dedicated scholarship counselor

Need a new computer for school?

Scholars currently enrolled in classes may receive a 90% reimbursement (up to \$500) on essential tech purchases, including laptops and tablets. Tech items must be purchased after scholars are approved and actively participating in T.E.A.C.H. to be eligible for this reimbursement.

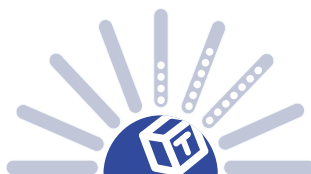
Can my program afford to sponsor staff (or volunteers) with a T.E.A.C.H. scholarship?

A typical investment for a program to sponsor a degree seeking scholar each semester is 10% of total tuition and granting the scholar paid release time of up to 3 hours per week. With T.E.A.C.H., sponsors are reimbursed for that release time at a rate equaling Florida's minimum wage plus \$2.00 per hour (up to 48 hours per semester for scholars working 30+ hours in the classroom). In many cases, T.E.A.C.H. owes the sponsor at the end of each semester. This means, as a sponsor, you have an instant return on your investment, and money is coming back to the program as you help your staff!

Turnover rates in the early learning profession are between 30-40% nationally. For T.E.A.C.H. Florida scholars, the turnover rate is less than 5%. As many directors know, staff retention can be expensive and time consuming. With the majority of our T.E.A.C.H. scholarship models, scholars make a commitment to stay at their program or in the ECE field following completion of their contract. Over the years, we have seen many scholars remain with their employer well beyond their required commitment period, with some moving to another scholarship as they continue to pursue their educational goals.

What does my program get in return for providing a raise or bonus upon completion of a T.E.A.C.H. contract?

You have early learning educators who are furthering their professional development, expanding their skill set, and applying effective instructional strategies in their classrooms. This is good for your program, great for your students, and even better for the families you serve. It's a win for everyone!

Frequently Asked Questions

Program Directors/Owners

Why does T.E.A.C.H. require the sponsoring program to provide 3 hours of paid release time?

When early learning educators have dedicated and guaranteed time for their studies, they are more successful in fulfilling their contracts with T.E.A.C.H. and meeting their professional goals within your program. Sponsors can schedule release time so that it is flexible for scholars and their program's needs.

What are some ways my program can provide paid release time to staff with a T.E.A.C.H. scholarship without writing a check?

T.E.A.C.H. provides reimbursement for release time that can be reinvested into staff to continue their education or used to cover bonuses and raises.

Below are some creative examples of how some sponsors have offered release time:

- Offer release time during children's rest time so scholars can study or complete school work.
- Pay scholars for holidays that they would not normally be paid.
- Allow scholars to accumulate release time, then provide a whole or half day off. This option will also give scholars dedicated time to complete assignments or prep for exams.
- Hire a substitute to cover your T.E.A.C.H. scholars. This option works best for programs that sponsor several educators.
- Pay scholars for their lunch breaks.
- Schedule release time when classroom ratios are low; for example, early in the morning or late in the afternoon.

What materials do I need to complete an application?

- Personal email address to create a portal account*
- Proof of Florida residency
- Proof of high school diploma (regionally accredited) or GED**
- DCF transcript dated within 90 days of submission
- Copies of ECE certificates and/or college transcripts
- Email address for the program where you are employed or volunteering
- DCF license number of the program where you are employed or volunteering***
- Name of the school or training program you wish to attend. **Check out the ECE Training Directory on our website for options available to you.**
- Many scholarship models require your employer to sponsor you and verify employment. Sponsoring employers must create and utilize a portal Business Account to provide this necessary information.
